

## NCCP EVALUATION CHALLENGE – NATIONAL TEAM ATHLETE

Gymnastics Canada provides an opportunity for for current and retired Canadian Senior National Team athletes who are actively coaching to ‘challenge’ evaluations, so that instead of taking the required courses and then completing the evaluation, the coach goes directly to the evaluation.

Coaches must apply for the opportunity to challenge an evaluation. The applicant must be a previously carded member of a Gymnastics Canada senior national team, aged 19 or older. Applications will be reviewed by Gymnastics Canada, who will determine the appropriate level of evaluation to challenge. This will be completed on a case by case basis. Some considerations may be given to special cases.

All applications must include a non-refundable cheque from the individual or organization requesting the evaluation challenge.

The fee for former national team athletes is **\$125.00**. They will be allowed to challenge either the Gymnastics Foundations Evaluation OR the Competition 1 Evaluation, depending on the level of athletes they are coaching.

The procedure to apply for the opportunity to challenge an evaluation is as follows:

- Applications must be sent directly from the coach or club to GYMNASTICS CANADA.
- Applications must be written, and must include:
  - A covering letter from the coach AND the club
  - An up to date resumé, which must include:
    - ~ Name
    - ~ Date of Birth
    - ~ Current address and telephone number
    - ~ *Brief* outline of National Team involvement (dates, profile)
    - ~ NCCP number
    - ~ Educational background
    - ~ Description of coaching experience
    - ~ List of NCCP courses already completed, and proof of completion
    - ~ Any other related information
- A minimum of 4 weeks is required to complete the application review process. Following the review, the candidate and the club will receive written notification from Gymnastics Canada as to the outcome. If the application is approved, Gymnastics Canada will provide the coach with an evaluation package and the contact information of potential evaluators.

***Incomplete applications will be returned to the candidate, and will not be reviewed until complete documentation is provided.***

### HERE’S HOW TO APPLY!

You must apply for the opportunity to challenge a Gymnastics Canada evaluation. Your application must be approved by Gymnastics Canada, at which time we will provide the coach with an evaluation package and the contact information of potential evaluators.

Please complete and submit the attached application form with all the required documentation (including the application fee, payable to Gymnastics Canada).
